The City Council is soliciting applications from residents who would like to serve on the Civil Service Board, Commission on Persons with Disabilities, Golf Commission, Historical Advisory Board, Housing Authority Board of Commissioners, Library Board, Planning Board, Public Utilities Board, Recreation and Parks Commission, Social Service and Human Relations Board, and Transportation Commission. The Civil Service Board was established by City Charter and is responsible for establishing and reviewing policies of the Civil Service system and making recommendations to the City Council. The Board meets the first Wednesday of each calendar quarter at 5:00 p.m.

The Commission on Persons with Disabilities (CPD) was established by ordinance to provide information and make recommendations regarding disability issues to the City Council and to receive information regarding the disabled from the community at large. The Commission meets the second Wednesday every other month at 6:30 p.m.

The Golf Commission was established by ordinance and advises the City Council on all matters concerning operational policies of the Alameda Municipal Golf Courses and such other golf facilities as may be established by or under control of the City. The Commission

meets the second Tuesday of every odd month at 6:30 p.m.

The Historical Advisory Board (HAB) was established by the City Charter “to encourage board community participation in the history of Alameda, and preserve and protect structures, sites and areas of historical significance in the City.” The Board meets the first Thursday of each month at 7:00 p.m.

The Housing Authority Board of Commissioners is the governing body of the Housing Authority of the City of Alameda. The Board has seven members, including two Housing Choice Voucher program tenant members (one of which is over 62 years of age). The Housing Authority Executive Director serves as the President and Chief Executive Officer. The Board meets the third Wednesday of each month at 7:00 p.m.

The Library Board was established by City Charter “to control and manage the Public Library System of the City”, “expend for library purposes all monies in the Library Fund” and “make and enforce rules and regulations necessary for the administration, government and protection of the Library System and its property.” The Board meets the second Wednesday of every odd month at 6:00 p.m.

The Planning Board was established by City Charter “to investigate and recommend plans for the future development, improvement and beautification of the City.” The Board administers regulations related to physical development, including the Zoning Ordinance, Subdivision Ordinance and Environmental Guidelines. A primary role of the Planning Board is the creation and maintenance of the City’s General Plan which defines the City’s future development policies and goals. The Board meets the second and fourth Monday of each month at 7:00 p.m.

The Public Utilities Board (PUB) was established by City Charter to control and manage the electric enterprise owned by the City of Alameda. The Board’s duties include adopting an annual budget; setting prices for all services and products; contracting for the purchase of materials, supplies, services, or such other commodities necessary for operation; and acquiring rights-of-way and real property (by lease or purchase in the name of the City) necessary for its purposes. The Board meets the third Monday of each month at 7:00 p.m.

The Recreation and Parks Commission was established by ordinance and provides advice, coordination and guidance on parks and recreational facilities. The Commission meets the second Thursday of each month at 7:00 p.m.

The Social Service Human Relations Board (SSHRB) was established by City Charter and assesses the social service needs of the community by encouraging the formation of private social welfare organizations to meet needs not already provided; foster mutual understanding, respect, and good will among community groups; assess and report to the City Council the social service needs of the people and methods to meet needs; and adopt a plan for performance functions. The Board meets the fourth Thursday of every month at 7:00 p.m.

The Transportation Commission was established by ordinance and advises the City Council on City transportation policies, through the development of transportation plans including, but not limited to: a Transit Plan, Bike Plan, Circulation Plan, Pedestrian Plan, and

Transportation Demand Management Plan, and shall monitor, via quarterly staff reports, the implementation of approved transportation plans and policies. The Commission meets the fourth Wednesday of every odd month at 6:30 p.m.
