City of Alameda Emergency Housing for the Homeless Community Meeting

November 29, 2021

SUMMARY NOTES

Introduction

The City of Alameda's Community Development Department sponsored a community listening session regarding the Emergency Housing for the Homeless Program on Monday, November 29, 2021, from 6:00 p.m. to 8:00 p.m. at the Albert H. DeWitt Officers' Club. The purpose of the meeting was to provide the community an opportunity to ask questions and share their concerns regarding the program.

City Public Information Officer Sarah Henry opened the meeting, welcoming community members to the listening session meeting and introducing City staff and a representative from Bay Area Community Services (BACS), the program provider. She introduced the meeting moderator Lou Hexter of MIG, Inc., who reviewed the purpose and agenda for the evening.

The City's Community Development Department staff provided a short overview of the program. Jonathan Russell, representing BACS, gave an overview of the organization's history, the services and support programs they offer, and what the program in Alameda would be like. The meeting was then opened for public questions and comments using submitted comments cards. Ana Padilla of MIG recorded these on a wallgraphic; a photo reproduction is provided at the end of this report.

This summary organizes written and graphically recorded questions and comments that arose in the meeting into themes.

Public Comments

Throughout the meeting, several key themes emerged regarding the overall program. These are listed below.

Process Concerns:

- Lack of transparent communication and information
- Legal qualification
- Lack of community consent
- Questions regarding redress for problems and issues
- Budget of the program
- Want more opportunity to speak

Neighborhood Concerns:

- Security
- Feeling unsafe
- Inappropriate behavior
- Lack of background checks for program participants
- Trash
- Quality and suitability of housing (lead paint, neglected repairs)

- High density (11 people to a unit)

- How and when will this be done?
- What are the motivations?
- Whom do we call when there are concerns/Immediate issues?
- What services will be offered to people in the homes?
- Why not use the barracks?
