Article 1. Insurance

Paragraph 17.4.1 of the Lease is hereby amended to change the amount of comprehensive general liability insurance, which the Authority is obligated to require its contractors or sublessees to carry, with respect to personal injury or death, from \$5,000,000.00 per occurrence to \$3,000,000,000 per occurrence and with respect to property damage from \$3,000,000 per occurrence to \$1,000,000 per occurrence.

Article 2. Survival and Benefit

- Unless defined separately, the terms used in this Amendment No. 1 shall be the same as used and defined in the Lease.
- Except as set forth herein, and unless modified specifically by this Amendment No. 1, all terms and conditions contained in the Lease shall remain binding upon the Parties and their respective successors and assigns as set forth in the Lease.
