Alameda Police Investigators have continued to work on this case to secure justice for the victim. During their investigation, a lead was developed using fixed automated license plate reader technology, and a suspect was identified. A search and an arrest warrant were issued based on the intelligence gathered. The suspect was taken into custody without physical harm to them or the officers.
