Guerra #19 called and reported the undetermined manner of death of a 26 year old male, identified as Mario Gonzalez Arenales who died at Alameda Hospital in Alameda. Officer Guerra informed me Alameda PD Officers attempted to detain Gonzalez Arenales at the 800 block of Oak Street in Alameda and a struggle ensued. Gonzalez Arenales resisted arrest and while being detained he became unresponsive. Officer Guerra began CPR at 1101 hours, Alameda Fire Unit 1 responded on scene and took over CPR at 1105 hours. Officer Guerra administered two doses of Narcan at 1105 hours. Gonzalez Arenales was transported to Alameda Hospital and life saving measures continued. Dr. Ari Edelheit pronounced his death at 1145 hours. Alcohol was found on scene.</p>
