2026 BOCCE BALL COURT RENTAL INFORMATION

LOCATION: LINCOLN PARK - 1450 High Street

DAYS: Monday, Wednesday, Thursday, Friday, Saturday, Sunday and Holidays: *(No Tuesdays)*

HOURS: Reservable time 9am to 7pm. Park hours are dawn to dusk, no loitering after dusk.

Please use our online reservation system to reserve the Bocce Ball Courts. Weekend rentals require a minimum of 3 hours. Reservations can be booked up to 6 months in advance.

The Bocce Ball rental is for bocce ball play only. Inside the fenced area, there are 2 courts, 2 picnic tables, and a grill. Because the space is fully enclosed, alcohol may be served **with an approved alcohol permit**. Please note that alcohol is **not** allowed anywhere outside the Bocce Ball courts in the park.

PERMITS

- Three-hour minimum is required to reserve the courts.
- Permits will be issued to adults 21 years and over.
- Your space is only guaranteed for the paid times listed on your permit.
- You must bring your own bocce ball equipment.
- Return the Bocce Ball site to its original condition and lock the gate when finished.
- Jumpers are not allowed in the bocce court area or with a bocce ball permit.
- The City of Alameda Resident fee will be automatically applied in the online reservation system.
- Military Personnel 10% Discount (Active and Non-Active) - Proof of Military I.D. required

CANCELLATIONS & RAINY DAY POLICY

A \$15 fee applies to all permit cancellations, and the remaining fees will be credited to your ARPD account for use toward another rental or ARPD activity. Credits only, no refunds.

If your bocce court reservation is rained out, please email the ARPD office at arpd@alamedaca.gov on the first business day following your reservation and your ARPD account will be credited for fees paid. Credits only, no refunds.

GATE PADLOCK CODE

The Bocce Ball courts are secured with a chain and combination padlock. You will receive the padlock code along with your permit number in your ARPD confirmation email. When your reservation is concluded, please be sure to replace the chain and padlock on the gate and confirm it is securely locked before you leave.

BBQ and PICNIC TABLE

There are two picnic tables and a charcoal grill inside the Bocce Ball Court area, which are included with your rental. Personal grills or other cooking sources are not permitted. Please leave any used or hot charcoal for our Park Maintenance Team to dispose of safely.

ALCOHOL

If you are planning to serve alcohol at your event, you must obtain a certificate of general liability insurance. <http://www.galescreek.com/app/index.cfm?jointpowers=1>. This must be completed 7 days prior to your event.

INSURANCE for VENDORS/CATERERS

Any caterers or vendors must be approved by ARPD prior to your event and provide a Certificate of Liability Insurance. A \$30 vendor fee will apply.

The City of Alameda requires proof of the Certificate of Liability Insurance with General Liability of at least \$1,000,000.00 and the City of Alameda must be endorsed to the policy as additionally insured under Certificate Holder with the following legal language:

- ***“The City of Alameda, and its members, officers, directors, agents, volunteers, employees and officials. 2263 Santa Clara Avenue, Alameda, CA 94501”***
